

# Clip Shoppe Groom & Board

## Boarding Contract

This is a contract between Clip Shoppe Groom & Board (hereinafter called "Clip Shoppe") and the pet owner whose signature appears below, (hereinafter called "Owner"). The signing of this contract is a one-time requirement and is activated at each boarding of owners pet or pets.

1. Owner agrees to pay the rate for boarding in effect on the date the pet is checked into the Clip Shoppe.
2. Owner further agrees to pay all costs for special services requested, and all veterinary costs for the pet during the time the pet is in the care of the Clip Shoppe.
3. Owner further agrees that the pet shall not leave the Clip Shoppe until all charges are paid to the Clip Shoppe by Owner.
4. I hereby authorize and guarantee payment for all services rendered. Although fees for services are due and payment expected at the time services are rendered, if I have been granted a grace period for payment of fees, I acknowledge that payment is due and expected at the time the billing statement is received. In the event that my account becomes delinquent for more than 30 days, I also agree to pay a finance charge of 1.5% per month on any balance due, as well as all reasonable collection costs not to exceed 50%, court costs, attorney fees and interest fees accrued with the collection of this account.
5. By signing this contract and leaving his pet with Clip Shoppe, Owner certifies to the accuracy of all information given about pet, which Clip Shoppe's liability shall in no event exceed the lesser of the current value of a pet of the same breed, or the sum of \$200 per pet boarded. The Owner further agrees to be solely responsible for any and all acts or behavior of pet while it is in care of the Clip Shoppe.
6. Owner specifically represents that he or she is the sole owner of the pet.
7. If owner does not contact the Clip Shoppe, or pick the pet up after 14 days past scheduled day of pick up the pet shall be deemed to be abandoned. The Clip Shoppe will then have authority to place pet in the protective care of a rescue group or humane society.
8. If pet becomes ill or if the state of the pet's health otherwise requires professional attention every reasonable attempt will be made to contact the Owner. If the Owner is unreachable, the Clip Shoppe, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the pet, and the expenses will be paid by Owner.
9. Any controversy or claim arising out of or relating to this contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this contract shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator shall, as part of this award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
10. Owner agrees that he/she is solely responsible for any and all damage that their pet may cause, to the kennel, attendants, other animals, or itself, through illness, malicious, or improper conduct.
11. The Clip Shoppe is not responsible for lost or damaged toys, bedding or any miscellaneous items. Please do not bring bedding or toys with stuffing.
